JANUARY 1, 2011, THE 111TH YEAR OF THE N.P.D.

The year 2011 began with the Norwich Police Force manpower shortened by one authorized position. Sgt Scott Meade, a member of the United States Air Force, New York National Guard component, began his second year of activation in the Global War on Terrorism.

Officer Craig Berry was appointed to fill Sgt. Meade's duties from a Civil Service list to the position of provisional Sergeant of Police. This promotion provided first-line supervision to a shift of police officers.

At the start of the year we anticipated at least two vacancies caused by retirement. One retirement vacancy was filled in 2010 with the hiring of PO Evan Romaine using Federal Recovery Acts funding. In February of 2011 the Common Council appointed George C. Carnrike III to the position of Police Officer to fill the other vacant position.

TWO BURGLARIES SOLVED QUICKLY

January 13, 2011— At about 2:00 a.m. POs Roach and Carpenter were patrolling on Silver Street and observed a lone subject walking in the middle of Berry Street. Because of the cold temperatures the officers thought it was prudent to check the welfare of the pedestrian. Upon turning their patrol car and returning to Berry St. the pedestrian could no longer be seen. Officers searched the area and discovered evidence of a break-in at a charitable organization's warehouse. Upon a further search of the area, the pedestrian was located, his shoes covered with socks, fleeing the scene. After the investigation, this male subject was charged with Burglary 3rd degree. Stolen property was returned to the rightful owners.

February 24, 2011— At about 1:30 a.m. the Norwich Police were requested to respond to a burglar alarm at a gas station on Rte 12 in the Town of Norwich, just north of the city line. POs Roach, Romaine & Carpenter, directed by 1stSgt Burlison, located a broken window at the rear of the building and footprints in the snow. Some officers patrolled the surrounding area in cars while other officers followed the tracks through knee deep snow. In the area of Valley View Trlr. Park, the suspect was located hiding in the brush. He was taken into custody with no resistance and turned over to the New York State Police.

Both of the examples above reflected great credit upon the Norwich Police and help us maintain our exemplary reputation with those we serve.

“MOVE OVER” LAW

January 1, 2011— New York became the 49th State to pass this long overdue law requiring motorists to ‘move over’ or slow down when encountering an emergency vehicle displaying flashing red lights. Thousands of times per year police officers must conduct some of their duties in or near the highway. This can be for a traffic stop or while investigating a motor vehicle accident. All are dangerous and can be fatal if a motorist is distracted. The law requires passing motorists to move one traffic lane away from the stopped emergency vehicle. If that is not possible, the motorist must slow down below the posted speed limit in order to pass by safely. New York was the last continental state to pass this law leaving Hawaii as the only state with no regulation of this type.

BRIEF CHASE LEADS TO DWI ARREST

February 15, 2011— At 1:50 p.m. a radio broadcast reported a female patron had shoplifted more than \$400 worth of items from a store on Rte 12 North. She left in a vehicle carrying several dvd movies and other merchandise. PO Annesi observed the vehicle on Cortland St. and attempted to stop the suspect. The female operator refused to pull over; and a brief chase ended on Pleasant St. when the suspect vehicle struck a Norwich patrol car driven by PO Miller. The suspect was taken into custody and it was found she was driving while intoxicated. She was charged by Norwich Police with DWI and possession of stolen property. After processing at the Norwich PD, she was turned over to sheriff's deputies for other charges relating to the original theft complaint.

WINTER WEATHER

Winter months in up-state New York can bring a wide variety of weather. Several storms over the season brought over 100 inches of snow for the winter season of 2010-2011. The Norwich Police used a 2004 Dodge 4X4 pick-up truck during most of these snow events. The Dodge truck was replaced in May of 2011 by a 2011 Ford F250 4X4 truck. The 2004 Dodge was 'sold' to the Norwich Fire Department for fire police use.



DOWNTOWN CROWS



For years crows have roosted in many of the trees in the downtown parks. These birds cause a nuisance by their droppings & from scavenging various sources of food. With park renovations to be completed later in 2011, the crows were no longer welcome. After others had attempted to move the crows from the area, the Norwich Police were able to dislocate these birds to new roosting locations away from the park. The use of non-lethal pyrotechnics proved to be successful and efficient.

SAINT PATRICK'S DAY FLAG RAISING

March 17, 2011 Sgt. Patrick Blenis and PO Michael Purdy, both officers of Irish descent, assist County Judge W. H. Sullivan in raising the flag of Ireland in West Park. This gathering of the Irish [and those who wish they were Irish] for the flag raising is a long standing tradition of which we are proud to be invited to each year.

OPERATION SAFE STOP

March 30, 2011 The Norwich Police in cooperation with the Norwich City School District participate in Operation Safe Stop. At least once per year extra officers are called in to supplement the on-duty officers to follow school buses throughout the city checking for compliance with the law for vehicles to stop for school buses with red lights flashing. Officers use both marked and un-marked vehicles during the morning and afternoon pick up and drop off of students.

SGT CRAIG BERRY RETIRES

April 15, 2011 Sgt. Craig Berry retired after 20 years of service to the City of Norwich. Craig began his career with the police department on March 17, 1991. During his service with the Norwich Police he was a recognized expert in motor vehicle accident reconstruction. He also excelled in the maintenance and repair of the departments computer systems saving the city thousands of dollars over the years of his employment.

PROMOTION TO SERGEANT

April 19, 2011 — Officer Rosario “Ross” Tumminia is promoted to Sergeant of Police during a meeting of the Common Council. Sgt Tumminia joined the Norwich Police on June 19, 1994. His new duties will be supervising a squad of patrol officers.



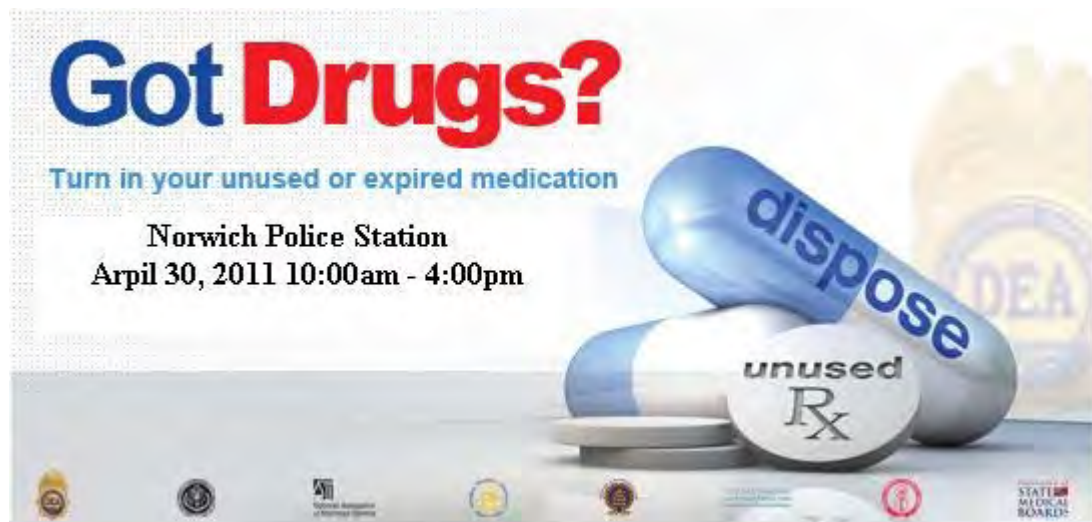

SEARCH WARRANT LEADS TO ARRESTS

April 6, 2011 — Detective Purdy received information from concerned residents about unusual activity at a house trailer on Rexford Street. Det. Purdy developed enough evidence to apply for a search warrant of the residence. Two subjects were charged with various drug related crimes. While still investigating at the address an additional female subject appeared at the residence who was found to be in possession of a large quantity of heroin and US currency. She too was charged with felony narcotics possession.

PRESCRIPTION DRUG TAKE-BACK DAY

April 30, 2011 The Norwich Police Department conducted the second Prescription Drug 'Take-Back' day. The first Take-Back day in September of 2010 was more successful than expected, so much so that a second day was scheduled. Norwich Police Officers set up a "No Questions Asked" Take-Back site at the rear of the P.D. building where citizens could turn in unwanted drugs and other controlled substances. Nearly 100 pounds of controlled and dangerous narcotics were collected. The collected items were then turned over to the U.S. Drug Enforcement Agency to be destroyed by burning in an incinerator at an undisclosed location.



APRIL SHOWERS AND MORE

April 27 & 28, 2011 — Heavy rain fell in the Central NY area for days, much of the rain came in the form of heavy thunderstorms dumping large amounts of water in a short time. This caused flash flooding and a rare F2 tornado in nearby Pharsalia Township. The Canasawacta Creek crested over South Broad St and soon overwhelmed the southern portion of the City.

A few hours later the Chenango River crested over East Main Street. Several city streets were flooded and many residents were displaced from damaged homes. An emergency declaration was issued locally, followed by declarations from the State and Federal governments. Norwich Police officers worked many hours in the terrible conditions directing traffic, responding to calls for help and assisting with evacuations.

RED MILL HILL BRIDGE FAILS

May 3, 2011 — Central New York was plagued with heavy rain for days. The ground completely saturated with heavy run-off occurring. On the evening of May 3, the police received a call from a Pleasant St resident reporting the Red Mill Hill bridge was making a 'groaning' noise. This bridge later completely failed when the piers were undermined by fast moving water. The bridge dropped into the Canasawacta Creek later that evening. During the summer of 2011 this bridge was removed by the Chenango County Highway Department after standing in place since 1893.

POLICE WEEK 2011 WASHING D.C.

May 16, 2011 Chief Joseph Angelino represented the Norwich Police Department in Washington, D.C. during National Police Week memorial activities.

WALNUT STREET HOUSE FIRE

May 26, 2011— Officers working the overnight watch were called by the 9-1-1 center reporting the odor of smoke in the area of Grove Ave and Midland Drive. Sgt Turner and POs' Zieno and Rotundo responded and began a search for the origins of the heavy smoke in the area. Knowing that something was burning, the officers alerted the Fire Department to the area. Prior the arrival of the firefighters, PO Zieno's attention was drawn to 12 Walnut St where he discovered flames showing through the house eaves. PO Zieno and a resident attempted to alert anyone who may have been in the residence. When this proved unsuccessful, PO Zieno and Sgt Turner forced entry into the smoke filled house from a different door but did not locate anyone inside. Firefighters soon arrived and conducted a thorough search that confirmed no one was inside the residence. The home was a total loss and the fire remains under investigation.

FOUR WHEEL DRIVE MOBILITY

May 2011 — The Norwich Police took delivery of a 2011 Ford F250 crew cab pickup truck. This truck was a scheduled replacement for a seven year old Dodge 4X4 truck. The new Ford truck is a 3/4 ton, replacing the older 1/2 ton truck. This truck will more efficiently tow the heavy trailer containing wooden barricades and traffic cones that are often used. A secondary use for this truck is winter weather use. This is the only four wheel drive vehicle owned by the police department.



DEPUTY CHIEF DALE SMITH RETIRES

May 28, 2011- Deputy Chief Dale Smith Jr. retired from the Norwich Police. Dale began his career on March 17, 1991. He was promoted to Sergeant in 1996 and then to Deputy Chief in 2006. Deputy Chief Smith predominantly worked as a Watch Commander during the evening shift, from 3 p.m.-11 p.m. In the photo at right Deputy Chief Smith is working the desk on Friday May 27th, coordinating activities of the Rolling Antiquer's car show security detail.

JULY 4TH FIREWORKS TRAFFIC DETAIL

July 4, 2011— The Norwich professional firefighters each year sponsor a 4th of July fireworks display at the fairgrounds on East Main Street. In 2011 the weather was perfect and a crowd of thousands was there, arriving in vehicles and on foot. NPD officers on foot patrol ensured the crowd remains 'family friendly'. Once the show was completed officers quickly, safely and efficiently, moved thousands of people and hundreds of vehicles from the fairgrounds by making East Main Street a temporary one-way street away from the fairgrounds.



GUS MACKER 3-ON-3 STREET BASKETBALL

July 8, 9 & 10, 2011— Thousands of people descend upon East Main St. for a weekend of 3-on-3 basketball. This worthwhile event requires NPD officers for the set-up, traffic detours, policing of the event and tear down once the tournament has ended. The NPD is supplemented by members of the county fire police to ensure a safe event.



DRUGS & WEAPON STASH LOCATED

July 12, 2011— A local landlord came to the police station reporting his tenants had abandoned their apartment abruptly, without notice. The landlord told officers he was not sure if their property or any squatters remained at the house. He requested officers to go with him while he checked on his property. PO Clarke and his K9 partner Weeks inspected the vacant residence. Weeks indicated the presence of illegal narcotics in the bedroom area. An initial search by PO Clarke turned up a quantity of marijuana. Additional officers responded to assist in the search during which a large amount of 'crack' cocaine and a loaded Jennings .22 caliber semi-automatic pistol were found hidden in the bedroom. All of this contraband was sent to the State Police crime lab for examination. If fingerprints or DNA evidence is located an arrest will be made.

DEPUTY CHIEF PROMOTION

July 19, 2011— Scott Burlison is promoted to Deputy Chief of Police during a Common Council meeting. Deputy Chief Burlison joined the Norwich Police in 1996. He was promoted to Sergeant in 2006. In 2009 he was given the designation of First Sergeant.



TWO POLE CAMERAS ADDED

During the summer months of 2011 two pole cameras were installed supplementing the North Broad St pole camera that has been in use since 2000. The two new cameras are located at the intersection of East Main St. and Silver St. and East Main St. at East Park Place. All cameras are capable of being remotely controlled from the Desk Sergeant's position at Police Headquarters.

COUNTY FAIR DETAIL

August 9-14, 2011— The Chenango County Fair takes place each year in August. Norwich and Watertown are the only two cities in New York that have a county fair within city boundaries. Each year the fair begins with the Fireman’s Parade on Midland Dr. and East Main Street. Supplemented by fire police, Norwich officers man the parade route and detour traffic. Throughout the week long event at least two Norwich officers patrol the grounds along with NYS troopers from Troop “C”. On Friday evening and during large grandstand attractions, additional officers are on hand. Norwich Police provide a presence on the grounds to ensure this great event takes place safely and peacefully.

MORE NASTY WEATHER HITS NORWICH

August 28, 2011— Hurricane Irene pounded the local area with rain fall of 4 inches and sustained heavy winds. Luckily the ground was dry and able to absorb much of the rain fall; but winds and weakened tree roots caused trees to fall all over the region. Several thousand residents in the area were without electrical power for days. Norwich police officers responded to several weather related calls for service.

SOCIAL MEDIA PROVES USEFUL

In August of 2010 the Norwich Police created a Facebook page as part of our ongoing community outreach efforts. The use of this social media proved to be more useful than expected. During flooding events real time information was posted from the Emergency Operations center alerting residents to road closures, locations of relief supplies and news updates. Photos & video of suspects have been identified and lost dogs returned to owners after being placed on social media web. As of December there were more than 3000 people listed as following the Norwich police activity.

STILL MORE NASTY WEATHER AND FLOODING

September 8, 2011—The remnants of Hurricane Lee hit the Chenango County area with relentless rain, winds and flooding. States of Emergency were declared all over New York State because of road washouts, downed power lines and overall dangerous conditions. The Chenango River & Canasawacta Creek both crested at record high levels causing damage to many homes in flood prone areas. The Red Cross set up shelters at various locations in the county to house evacuated residents. Schools that had only been open for one day were closed because of this natural disaster.



COLORSCAPE ARTS FESTIVAL

September 9, 10, & 11, 2011— The Colorscape Arts Festival took place for the 17th year. Usually this event draws 8000-10,000 visitors to downtown Norwich. This year because of impassable roads and flooding the crowd was considerably less, but the event still took place. Norwich police officers protect the valuable exhibits 24/7 during this event.

During the day officers & fire police assist thousands of pedestrians cross busy NYS Route 12.

10TH ANNIVERSARY OF THE 9/11 ATTACKS

September 11, 2011— The New York State Museum in Albany, NY brought several artifacts from their collection to the Chenango County Arts Council gallery for residents to reflect on the attacks 10 years earlier. The exhibit also included items from the Norwich Police and Fire Departments. Shortly after the September 11, 2001 attack in New York City a contingent of Norwich Police delivered relief supplies and cash to the NYPD and NY/NJ Port Authority Police Departments. In appreciation for our efforts, the NYPD arranged for delivery of World Trade Center steel and concrete remains to the Norwich Police Station. These items were loaned to the Council of the Arts to supplement the NYS exhibits.

N.H.S. FOOTBALL

Officers of the Norwich Police attend all varsity football games during the months of September, October and November. At least two officers, and sometimes more, patrol the grounds, unlock car doors, give directions to visiting spectators and escort visiting team busses.

SEARCH WARRANT RAID NETS ILLEGAL DRUGS

October 15, 2011— At 6:04 a.m. no-knock search warrants were executed at two separate apartments in a North Broad St. building. This raid was conducted by Norwich officers and Sheriff's deputies after a lengthy investigation into the sale of cocaine and heroin by residents and visitors to the apartments. Quantities of marihuana, cocaine, prescription narcotics, heroin, US currency and other paraphernalia were seized. Five people were arrested and currently await court proceedings.

HALLOWEEN SAFETY

To prepare for the usually busy Halloween and Trick-or-Treating, officers of the Norwich police spend two days in the elementary schools teaching and reminding young students of the safe practices to follow while enjoying the holiday.

The night of Halloween several extra officers are scheduled for duty to ensure a safe environment. Each officer is assigned to a small area to patrol to provide a highly visible reminder to other young adults.

NEWEST ADDITION TO THE FORCE

October 28, 2011— PO George Carnrike III graduated from the Police Academy in Binghamton, NY. PO Carnrike backfilled a vacancy created by a retirement earlier in the year. PO Carnrike is a life long city resident and begins a long career that will continue until at least the year 2031.



Y.M.C.A. TURKEY TROT

November 20, 2011— Running enthusiasts from all over Central New York participate in the YMCA annual Turkey Trot 5K road race. This race course travels into 5 of the 6 city wards. In 2011 nearly 700 runners were registered and hundreds more were spectators. This event requires the use of fire police to ensure runners can safely cross busy intersections along the route.



CHRISTMAS PARADE OF LIGHTS

November 26, 2011— Of the several parades we assist with each year, the Christmas Parade is by far the largest. All of the Norwich Police force were working on that evening; clearing parking spaces, setting up a detour route, leading the parade and patrolling the barricade line. After the parade is over, hours of work remain to break down barricades, collect traffic cones and close the detour route; all well worth the time and effort.



2A.M. PARKING TICKET SURPRISE

Each winter officers on the night watch patrol all city streets checking for vehicles parked in violation of the 2 a.m.-6 a.m. parking ban. The overnight winter parking ban assists the DPW with efficient snow removal from November to April. On the morning of November 1, 2011 at 2:30 a.m., the very first night of the parking ban, PO Timothy Annesi discovered a parked truck on Silver Street that was engulfed in flames. PO Annesi expended all on-hand fire extinguishers to fight the blaze until the Fire Department arrived.

HEROIN & CRACK IN THE TOILET

December 20, 2011— At approximately 9:30 p.m. PO Thomas Miller was conducting a walk-through foot patrol of a downtown hotel in response to a complaint of marijuana burning. PO Miller and PO Timothy Annesi soon found a female guest who admitted to causing the burning smell. Once at her room officers encountered another out of town guest in the room with a barricaded door. Officers heard the distinctive sound of movement in the bathroom area. It was probable that evidence was being destroyed and the officers made entry. Once inside they found the bathroom in disarray. Officer Miller discovered a plastic bag in an overflowing toilet. With the use of a shop-vac the officers were able to retrieve large quantities of packaged heroin and crack cocaine. Also found in ceiling tiles was a quantity of marijuana. Norwich officers were assisted by an on-duty Sheriff's K9 unit. Two suspects were charged with several felonies and this case is in the court system awaiting prosecution.

DWI ENFORCEMENT

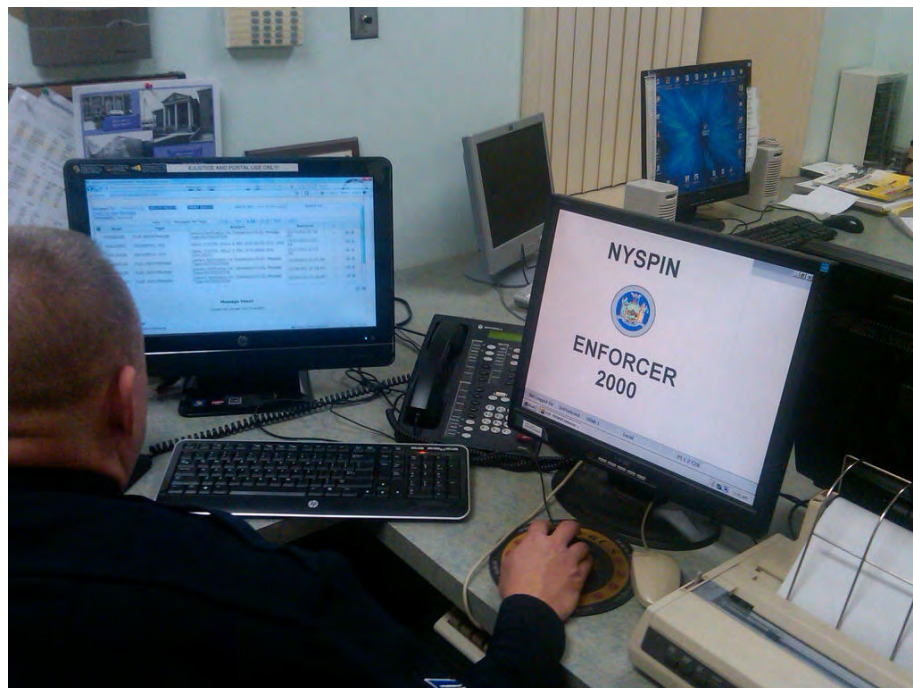
Each year the Chenango County STOP-DWI program earmarks approximately \$16,000 to the Norwich Police. This money is used to add patrols for enforcement of drunk driving and associated laws. These patrols normally are scheduled on weekend evenings. During December of 2011 the New York State law enforcement community made an appeal to have no fatalities during the holiday period of Thanksgiving to New Year's Day. The Norwich Police participated in this initiative by scheduling 80 hours of DWI patrols during the holiday period. During this initiative Norwich Police officers made eight DWI arrests, one on New Year's Eve.

THINGS WE WON'T SEE ANYMORE

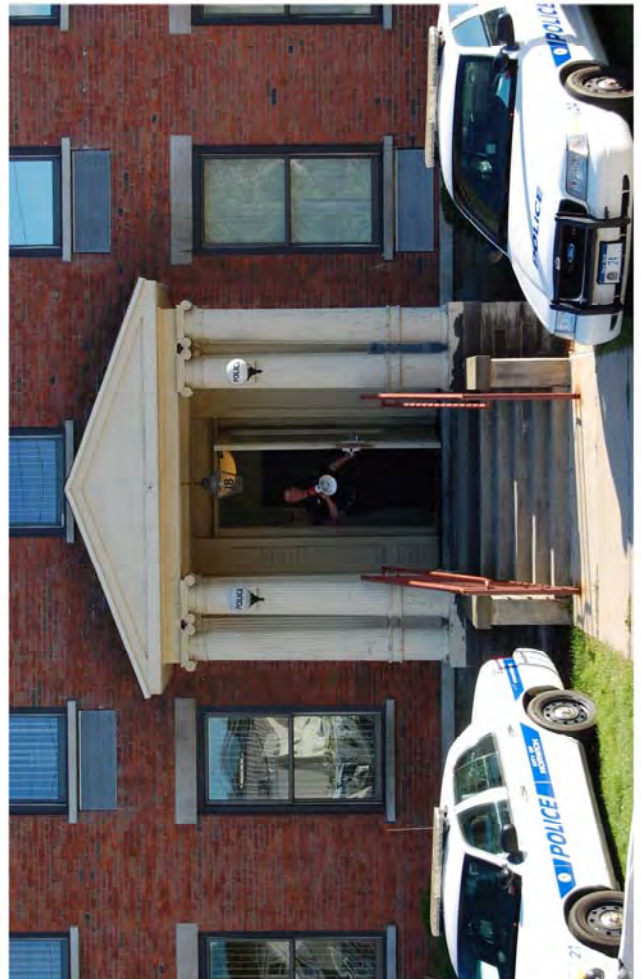
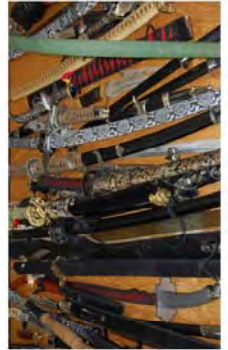
During the year 2011 the profession of law enforcement saw the end of two proven law enforcement tools: 1. The Ford Crown Victoria P71 patrol car and 2. The NYSPIN teletype terminal. The P71's in the photo below are the last of a fleet of Ford patrol cars that have been used exclusively by the Norwich Police for sixteen years.



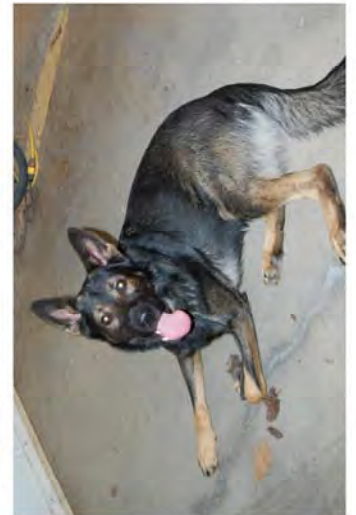
Below on the right is the NYSPIN teletype terminal and its dot matrix printer. This system, and its improvements, remained much the same over the past 40 years. The sound of the printer automatically rattling out teletype messages went silent in December. The replacement, to the left, is the internet based E-Justice web portal used by officers to receive DMV & criminal messages and deliver our messages to other agencies.
